Rules and Process for Including Applicants (Sports and Leisure Facilities) into the MultiSport Benefit Portfolio Offer

1. The cooperation offer is exclusively for owners of sports and relaxation facilities.
2. These facilities must primarily provide services that are included and offered in the MultiSport Benefit network. The inclusion of new partners will be considered in the order in which they were submitted.
3. We will only contact the owners of facilities that meet all the criteria.
4. Cooperation can only be established with an existing and operational operator who already provides sports/relaxation services.
5. Cooperation can only be concluded if the provider has provided us with truthful information.
6. We include services/activities that are nationwide, available, and can be included in the network at least in Prague, Brno, and Ostrava.
7. The provider's services/activities must be available to all MultiSport cardholders, meaning that lessons/activities held at the headquarters of a specific company and intended only for employees of that company, individual and private lessons/activities cannot be included.
8. For group lessons, we prefer to include activities that meet the basic definition of a sports activity. For specialized/new activities, we require certification or a trademark that should guarantee the quality and functionality of these services.
9. Group lessons must be „open“; courses cannot be included.
10. The minimum capacity for group lessons must be at least 8 people.
11. The sauna world with a surcharge must offer at least four saunas and other supplementary activities such as a whirlpool, Kneipp path, cooling pool, etc., within the premises for a single entry. There must also be sufficient demand and interest from MS clients.
The time allowance for entry is at least 90 minutes (120 minutes), where part of the entry is paid for by the MS card, the rest is paid on-site by the MS cardholder according to the pre-set conditions and amounts, which are published on the MS website. After exceeding the given time limit, the client pays the amount according to the partner's price list.
12. The InBody service can only be included in the cooperation for facilities where we have at least one other activity included in the cooperation.
13. We do not include machine activities such as Vacushape, BetterBelly, Rolletic, vibration platforms, lymphatic drainage and massage or cosmetic services in the cooperation.
14. MultiSport Benefit may grant an exception to the inclusion in the portfolio after individual examination if the applicant does not meet one of the above conditions.
15. MultiSport Benefit reserves the right not to include a partner in the portfolio even if all the above conditions are met (e.g., user-unfriendly activities, capacity fulfillment within a defined territory, etc.).
